Details of Organiser's administrative authorisation:

- **Mandatory insurance**

- details of the travellers' guarantees pursuant to Article 47 TC:

The policy envisages the reimbursement of the price paid for the purchase of the travel package, in addition to any expenses incurred for the immediate return of the Participant, in the event of travel abroad (only if the package includes transportation of the Participant), within the limits of the maximum of €350,000.00 (three hundred and fifty thousand Euros).

The guarantee shall apply only if:

(i) the Organiser's state of insolvency has been legally ascertained by a measure that can no longer be challenged;

(ii) the performance due to the Participant has not been carried out in full, as the above measure was taken prior to the provision of the services included in the package;

(iii) the credit for the refund of the price has been ascertained as part of the Organiser's insolvency procedure;

The breaches must be reported within the limitation period of 3 months from the expiry of the guarantee indicated above.

- details of the civil liability insurance policy:

Limits: Public Liability primary liability up to € 2,000,000.00 per claim, € 2,000,000.00 per injured party, € 2,000,000.00 for damage to property and third parties + professional liability € 2,000,000.00;

Public Liability secondary professional liability from € 2,000,000.00 to € 31,500,000.00

- accident policy:

The guarantee covers accidents suffered by Participants at the Juventus Summer Camp and is effective from the time the Participant is dropped off until being returned to the parent/guardian.

The insured sums and the indemnity limits are understood to be per person:

permanent invalidity – insured sum €150,000.000

death – insured sum €100,000.00

refund of medical expenses - maximum €5,000.00

1. Costs for hospitalisation fees, medical assistance, treatments, physiotherapy and rehabilitation treatments, medicines and examinations, costs for surgical interventions, and more specifically the fees of the surgeon, anaesthetist and any other person participating in the surgery, operating theatre fees and surgical material, therein including therapeutic equipment and endoprostheses applied during the surgery;
2. Costs for specialist examinations and medical assessments, therein including medical fees, consequent to the accident;

3. Costs for the purchase of prosthetic devices, rendered necessary by the accident, including dental prostheses

The refund is paid once the treatment is completed, upon submission of the original fee notes, itemised lists and receipts, duly receipted, subject to deducting a percentage excess of 20%.

Note that the accident policy is in the name of Holiday System S.r.l. with registered office in Mori (TN) – Via Giacomo Matteotti, 1/e 38065 – Tax Code and VAT number 01554560225, in the capacity of organiser and provider of the tourism services included in the package. In the event of a claim, the Participant intending to activate the accident policy must contact Holiday System S.r.l.

- **Catalogue Validity**

The catalogue offered on the Website camp.juventus.com (hereinafter, the Website), the respective prices and the general terms of sale are valid until 8 August 2022.

- **Package characteristics**

The Juventus Summer Camp package concerns summer football courses in the tourism locations indicated on the Website, split into weekly periods on an “all inclusive” basis. Juventus Summer Camp is aimed at children between the ages of 8 and 17 years old;

With the exception of the “Girls Camp” dedicated to girls, all other packages offered on the Website are aimed exclusively at boys.

THE PARTICIPATION FEE INCLUDES:

- administration fee;
- full board: breakfast, lunch, dinner and one break per day (according to a menu with different selections designed with the collaboration of our experts);
- accommodation in rooms with 2, 3 or 4 beds;
- supervision and assistance service;
- medical assistance;
- third party civil liability insurance;
- accident insurance;
- welcome kit, as specified on the Website;
- training and technical education with staff from the Juventus projects, made up of FIGC licensed coaches and/or graduates in motor sciences;
- staff dedicated to leisure time entertainment;
- tour of the Juventus Stadium in Turin, with a visit to the Museum, for participants at the Black & White Camp and for participants in the Summer Camp Sestriere.
- air transport, airport costs and taxes and transfer by GT coach from the airport to Ardingly College and vice versa, for the Juventus English Camp Ardingly package only;
- entry and exit taxes, for the Juventus English Camp Ardingly package only;
- English language course taught by qualified native speakers, for the Juventus English Camp Ardingly package only;
- trips and excursions as stated in the catalogue on the Website for the Juventus English Camp Ardingly package, for the MasterClass Camp Turin package and for the Juventus Summer Camp Sestriere package;
- certificate of participation and final gadgets.

With the sole exception of the Juventus English Camp Ardingly package, transportation from and to the place of residence of the Participant is not included in the services provided.

- **Language in which the services are provided**

The assistance services are provided in Italian and/or English, the entertainment and training services are provided by Italian staff who speak Italian and, generally, also English. The remaining services (for example, catering, reception) are provided in Italian.

The services of the Juventus English Camp Ardingly package are provided in English.

The rooms are generally assigned after 3:00 p.m. on the day of arrival and will need to be returned by 9:00 a.m. on the day of departure.

- **Information for Participants with reduced mobility**

In view of the fact that football courses represent the basic element of the Juventus Summer Camp package, to assess whether or not the package is suitable for a person with reduced mobility, at the request of the Parent, based upon the medical documentation, precise information will be provided on the suitability of the package which takes account of the specific requirements of the child.

- **Cancellation of the package in the event of failure to reach the minimum number of participants**

The services relating to the Juventus Summer Camp packages are provided by the Organiser within a group and the performance of the services is subject to reaching the minimum number of Participants as specified below:

The Organiser reserves the right to cancel the package in the event of failure to reach the minimum number of Participants indicated above, by written notice sent at least 20 days before the start date of the package.

In this case, Article 10 of the General Terms of Contract will apply.

- **Payments (Art. 7 of the General Terms)**
- i. For purchase offers sent by 8 May 2022:
- the Purchaser must pay an advance deposit on the Total Price, which includes an deposit on the Participation Fee and the full cost of the Early Cancellation, if signed, at the same time as sending the Order Form and in any case within 7 days of the date of sending the Order Form.

- ii. For purchase offers sent after 8 May 2022, the Purchaser must pay the Total Price, including the cost of the Early Cancellation, if signed, at the same time as sending the Order Form.

The Total Price may be paid by credit card (Visa and Mastercard) or debit card or by MyBank online transfer.

- iii. For bookings made exclusively in the period between the opening of registrations and 8 May 2022 it is also possible to choose the financed payment method by way of a Sella Personal Credit S.p.A. finance (hereafter “Sella Personal Credit”). In this case, the Purchaser will be directed to the online platform of Sella Personal Credit where they must enter the necessary details to apply for the loan and, by and not beyond the next 7 days, must send to Sella Personal Credit the documentation requested by the latter to finalise the finance contract. The finance contract will be formalised between the Purchaser and Sella Personal Credit, with no liability or obligation for the Organiser. The financed sum will refer to the Total Price to be paid (including the Participation Fee and the amount of the Early Cancellation, if signed). If Sella Personal Credit does not authorise the requested loan, the Purchaser must make the payment of the Total Price directly.

- **Withdrawal from online sale - exclusion of the right of withdrawal**

The agreement, being classified as a “distance contract” in accordance with Article 45, 1st paragraph, letter g) of the Consumer Code (“*any contract signed between the Professional and the consumer as part of an organised distance sale or service provision scheme without the simultaneous physical presence of the Professional and the consumer, through the exclusive use of one or more means of distance communication until the conclusion of the contract, including the conclusion of the contract itself*”) is not subject to the exercise of the right of withdrawal, in accordance with Article 47, paragraph 1, letter g) of the Consumer Code, which governs and lists the cases of exclusion. Without prejudice to the foregoing, the Participant will have the right to withdraw from the contract at any time prior to the start of the package subject to paying the withdrawal costs (penalties) indicated in the item “Participant's Withdrawal and Penalties”.

- **Participant's Withdrawal and Penalties (Art. 11 General Terms)**

In the event of the withdrawal from the contract by the Participant prior to departure, for any reason, even unforeseen and unexpected, beyond the cases envisaged by Article 40, paragraph 2 and Article

41, paragraphs 4 and 7 of the Tourism Code and Art. 11 of the Summer Camp General Terms, a penalty will be charged.

The amount of the penalty will be calculated by adding together any cost of the Early Cancellation, if signed, the cost for other services requested and already rendered, and the following percentages of the participation fee, calculated on the basis of how many days prior to the start of the package the cancellation occurred (the calculation of days does not include the withdrawal, notice of which must be received on a working day prior to the start of the package):

- more than 21 days prior to departure 25%;
- from 20 to 5 days prior to departure 50%;
- from 4 to 0 days prior to departure 90%;
- once the stay has started 100%.

- **Replacement Conditions (Art. 14 of the General Terms)**

The methods and terms of replacement are governed by Article 14 of the Summer Camp General Terms.

- **Necessary documents for using the package (Art. 15 and 16 of the General Terms)**

(i) Identity card or individual passport (mandatory for the Camp Calcio + Inglese package) or personal document valid for travel abroad, in addition to the requirements indicated, with regard to the exit from the country of children under 14 years of age and for those for whom an authorisation issued by the Judicial Authority is required, on the website of the Italian State Police, <http://www.poliziadistato.it/articolo/191/>;

(ii) Certificate confirming the absence of infectious syndromes;

(iii) Registration form to be completed digitally by the Parent via the link sent to the email address of the latter;

(iv) Medical certificate of fitness for competitive or non-competitive sporting activity;

(v) Clearance from the relevant club in the case of a Participant who has already reached 14 years old and has multiyear membership;

(vi) Shockproof goggles with celluloid frame and shatter-proof graduated polycarbonate lenses (if glasses are worn);

Furthermore, based upon the prevention measures laid down by the legislation to contain the Covid-19 pandemic risk, at the date of commencement of the package, to access tourism services and/or to carry out sporting activity, the Covid-19 Green Pass may be requested and it may be necessary to wear personal protective equipment. The Participant is required to find out about the specific regulatory requirements in force at the date of the package.

Foreign citizens must find the information for entry to Italy through their diplomatic representations in Italy and/or follow the information and instructions for entry to Italy published by the Italian Ministry for Foreign Affairs (<https://vistoperitalia.esteri.it/home.aspx>). In any case, the Participant must check, before departure, with the competent authorities, making any necessary changes prior to travel.

The Purchaser must in any case inform the Organiser of the citizenship and residence of the Participant at the time of the booking request for the package and, at the time of departure, must definitively ensure that they hold individual identity documents and any other valid documents, as well as any visas for their stay or transit, and any health certificates that may be required.

Moreover, in order to evaluate the socio-political, health and other useful information concerning the destination country and, therefore, the objective usability of the services purchased or those to be purchased, the Purchaser is obliged to obtain general official information from the Ministry for Foreign Affairs, published on the Farnesina institutional website www.viaggiare Sicuri.it.

The information above is not contained in the online or paper catalogues of the Tour Operator, since they contain general descriptive information as indicated in Article 34 of the Tourism Code and information that does not change over time. The same must therefore be obtained by the Purchaser and the Participant. The Organiser will not be liable for any damage that may be caused to Participants due to the impossibility of commencing and/or continuing the journey, due to the lack of or irregularity of the required documents and/or the failure to respect the health requirements and respective formalities for the destination country. The Organiser may not, therefore, be held liable for the Participant's failure to depart and will not, therefore, provide any refund of the price of the stay or supplementary costs (cancellation, repatriation, hotel, taxi, etc.).

For further information, reference is made to Articles 15 (“Mandatory declarations and Certificates necessary to use the package to be sent prior to the start of the trip”) and 16 (“Participant's Obligations”) of the Summer Camp General Terms.

- **Insurance against cancellation costs (Art. 23 of the General Terms)**

The participation fee does not include insurance for cancellation costs. It is possible to enter into, when making the booking of the package tour, the Early Cancellation agreement which operates only in certain circumstances. It is also possible to enter into special insurance policies against cancellation costs of the package. In that case, the rights arising from the insurance contracts must be exercised directly in relation to the insurance companies involved, under the conditions and by the methods envisaged by those policies.

- **Privacy policy pursuant to Article 13 of Italian Legislative Decree no. 196/2003 and Article 13 of Regulation (EU) 2016/679**

The data communicated by the Purchaser, necessary to execute the package contract, are processed in accordance with the provisions of the aforementioned legislation (European Regulation 679/2016 and Legislative Decree 196/2003 as amended) and the confidentiality obligations to which the Organiser is bound in relation to personal data protection. The personal and special data are processed as part of the Summer Camp package to allow for the management of the order form, the conclusion and execution of the package contract, to provide support services and to manage payments. For the performance of the services covered by the tourist package agreement, the data are communicated to the suppliers of the services included in the tourist package. The data subjects may at any time exercise the rights that the applicable law regarding the protection of personal data attributed to them. For any further information on personal data processing by the Organiser, see the specific Privacy Policy for Juventus Summer Camps published in the Camp Legal Information section.

- **Mandatory notice pursuant to Article 17 of Italian Law no. 38/2006**

Italian law punishes crimes concerning prostitution and child pornography with imprisonment, even if committed abroad.

EARLY CANCELLATION

The “Early Cancellation” agreement allows for the Camp to be cancelled for one of the reasons listed below, objectively certified and documented:

- hospitalisation (excluding Outpatients and Accident and Emergency) or death of the Participant or a relative (whereby “Relative” means cohabiting relatives as reported in the respective family status certificate, parents and grandparents)
- sicknesses and/or accidents suffered by the Participant or a Relative that impedes the Participant's participation at the Camp
- exam failure or repeat exams of the Participant

If the Camp is cancelled, the Total Price paid by the Purchaser will be returned.

In the case of one of the events that give the Participant the right to the Early Cancellation, the Participant must communicate the cancellation within five calendar days from the occurrence of the cause (or by the start date of the Camp if the term of five days falls after the start date of the Camp), sending the Camp cancellation notice by email to camp@juventus-academy.com indicating the reason for the cancellation and submitting the necessary documentation:

- in the case of sickness/accident, medical certificate certifying the impossibility of participating at the Camp;
- in the case of hospitalisation, certified copy of the original of the hospitalisation declaration with duration and date of discharge;
- in the case of death, death certificate;
- certification of the kinship relationship with the Participant if the negative event occurred to a family member;

- in the case of exam failure or repeat exams, the final outcome of the examination.

The Early Cancellation only operates for the reasons indicated above. The cancellation of the Camp for any other reason, if not expressly envisaged and regulated in the General Terms, does not give any right to a refund of the price. The refund of the price is also excluded if the Participant has not communicated to the Organiser the formal cancellation of the Camp, within five calendar days from the occurrence of the cause of modification/cancellation itself or by the start date of the Camp if the term of five days indicated above falls after the start date of the Camp.

Subject to the obligation to exercise the Early Cancellation within the term indicated above, the Early Cancellation may be exercised by the date of conclusion of the Contract (which is finalised with the payment of the Total Price) until the start date of the Camp itself, whereby start of the Camp means the time the Participant should have attended at the Camp.

In order for the Early Cancellation to be effective, the option must be signed at the same time as booking the Camp.

The Organiser will refund the Total Price within 14 working days from receipt of the complete documentation, subject to verifying the existence of the causes that entitle the participant to cancel the Camp.
