- **Compulsory insurance**

- details of the guarantees for travellers pursuant to Article 47 of the CdT:

Surety policy no. 40324512001219 stipulated with Tua Assicurazioni S.p.A., Largo Tazio Nuvolari 1, 20143 Milan, tel: 800 533 533 which ensures, in the event of insolvency or bankruptcy of the Organizer, the reimbursement of the price paid for the purchase of the tourist package, in addition to any expenses incurred for the immediate return of the Participant (in the case of travel abroad), within the limits of the ceiling of Euro 270,000.00 (Euro two hundred and seventy thousand/00).

The guarantee referred to in the previous paragraph applies only in the event that:

- a. the state of insolvency of the Organizer has been judicially ascertained by means of a measure that can no longer be enforced;
- b. the service due to the Participant has not been fully performed, since the above measure was taken before the provision of the services provided for by the tourist package;
- c. the claim for the reimbursement of the price has been ascertained as part of the Organizer's insolvency proceedings.

- Details of the civil liability insurance policy:

Maximums: 1st risk civil liability up to € 6,000,000.00 per claim, € 6,000,000.00 per injured person, € 6,000,000.00 for damage to property and third parties

- Accident policy:

The guarantee stipulated with the ITAS Assicurazioni company covers accidents suffered by Participants in the Juventus Summer Camps and operates from the moment the Participant is taken over until the return to the parent/accompanying person.

The sums insured and the limits of compensation are per person:

Permanent disability – sum insured € 150.000,000

Death – sum insured € 100.000,00

Reimbursement of medical expenses – ceiling € 5.000,00

1. Expenses for hospital fees, medical assistance, care, physiotherapy and rehabilitation treatments, medicines and examinations, expenses for surgical interventions, and specifically fees of the surgeon, anesthesiologist and any other person participating in the operation, operating room fees and intervention material, including therapeutic devices and endoprostheses applied during the operation;
2. Expenses for specialist examinations and medical examinations, including medical fees, resulting from the accident;
3. Expenses for the purchase of prosthetic appliances, necessitated by the accident, including dental prostheses

The reimbursement is made at the end of the treatment, upon presentation of the originals of the relevant notes, bills and duly receipted receipts, after deduction of an overdraft of 20%.

- **Catalogue Validity**

The catalogue proposed on the camp website [juventus.com](http://juventus.com) (hereinafter the Site), the relevant prices and the general terms and conditions of sale are valid until 12 August 2024.

- **Package Features**

The Juventus Summer Camp package consists of summer football courses in the tourist resorts indicated on the Site, divided into weekly shifts with an "all inclusive" formula. Juventus Summer Camp is aimed at children between the ages of 8 and 17.

With the exception of the "Girls Camp" dedicated to girls, all other packages offered on the Site are aimed exclusively at boys.

**THE PARTICIPATION FEE INCLUDES:**

- practice management fee;
- Only Residential Camps and English Camps: full board: breakfast, lunch, dinner and one break per day (according to a menu designed with the collaboration of our experts with a choice);
- Residential Camps and English Camps only: accommodation in rooms with 2-3-4 beds;
- Non-Residential Camps only: lunch and one break per day (according to a menu designed with the collaboration of our experts with a choice);
- surveillance and assistance service;
- medical assistance;
- RCT insurance;
- Accident insurance;
- welcome kit, as specified on the Site;
- training and technical instruction with the staff from the Juventus projects, made up of FIGC licensed coaches and/or graduates in sports science;
- staff dedicated to leisure entertainment and animation;
- tour of the Juventus Stadium in Turin, with a visit to the Museum, for the participants of the Masterclass Camp and for the participants of the Summer Camp Sestriere.
- air transport, airport charges and taxes and transfer by GT coach from the airport to the College and vice versa for Juventus English Camp packages only;
- English language course taught by qualified mother-tongue teachers for Juventus English Camp packages only;
- trips and excursions as they may be listed in the catalogue on the website;
- certificate of attendance and final gadgets.

With the exception of the Juventus English Camp packages, where air transfers are provided from the airports of Milan and Rome, transport to and from the Participant's place of residence is not included in the services provided.

- **Language in which the services are provided**

Assistance services are provided in Italian and/or English, entertainment and training services are provided by Italian and generally English speaking staff. The remaining services (e.g. catering, reception) are provided in Italian.

- **Information for Participants with Reduced Mobility**

In consideration of the fact that football courses represent the basic element of the Juventus Summer Camp package, in order to assess whether or not the package is suitable for a person with reduced mobility, at the request of the Parent, on the basis of the medical documentation provided, precise information on the suitability of the package will be provided that take into account the specific needs of the child.

- **Cancellation of the package in case of failure to reach the minimum number of participants required**

The services related to the Juventus Summer Camp packages are provided by the Organiser as part of a group and the provision of services is subject to the achievement of the minimum number of Participants as specified below:

The Organizer reserves the right to cancel the tourist package in the event of failure to reach the minimum number of Participants identified above with written notice at least 20 days before the start date of the package.

In this case, Art. 10 of the General Terms and Conditions.

- **Payments (art. 6 of the General Terms and Conditions)**

For bookings made by 8 May 2024, the Purchaser must pay a deposit on the Total Price (hereinafter "Deposit"), which includes a deposit on the Participation Fee and the full cost of the Facilitated Cancellation, if signed within 7 days from the date of sending the Order Form by credit card or bank transfer.

The balance of the Total Price must be paid by bank transfer:

Payment is deemed to have been made when the sums are received by the Organiser.

- i. For purchase proposals sent after 8 May 2024, the Buyer must pay the Total Price, including the cost of the Facilitated Cancellation, if signed, at the same time as sending the Order Form.

Payment of the Total Price can be made by credit card (Visa and Mastercard) or prepaid card or by bank transfer.

- ii. At the time of sending the Order Form, the Purchaser may also, if provided by the Organiser for the package selected at the time of purchase, choose the financed payment formula, which can be optioned in the booking process, through financing offered by the partner Compass S.p.A. with the Pagolight tool, (hereinafter "Pagolight"). In this case, the Buyer will be directed directly to Pagolight's online platform where he/she will have to enter the data necessary to apply for the loan and, no later than the following 7 days, he/she will have to send Pagolight the documentation requested by the latter for the finalization of the loan contract. The financing agreement will be formalized between the Buyer and Pagolight, without any liability or obligation on the part of the Organizer. The amount financed will refer to the Total Price to be paid (including the Participation Fee and the amount of the Facilitated Cancellation, if subscribed). In the event that Pagolight does not authorise the requested financing, the Buyer shall pay the Total Price directly.

- **Withdrawal from online sales - exclusion of the right of withdrawal**

The contract, as it falls within the category of "distance contracts" pursuant to Article 45, paragraph 1 letter g of the Consumer Code ("*any contract concluded between the Professional and the consumer within the framework of an organized regime of distance sale or provision of services without the physical and simultaneous presence of the Professional and the consumer, through the exclusive use of one or more means of distance communication until the conclusion of the contract, including the conclusion of the contract itself*") is not subject to the exercise of the right of withdrawal, pursuant to Article 47, paragraph 1, letter g) of the Consumer Code, which regulates and lists the cases of exclusion. Without prejudice to the above, the Participant shall have the right to withdraw from the contract at any time prior to the commencement of the package upon payment of the withdrawal fees (penalties) indicated below under the heading "Withdrawal of the Participant and penalties".

- **Withdrawal of the Participant and penalties (art. 11 General Conditions)**

The withdrawal from the contract by the Participant before departure, for any reason, even unforeseen and occurring, except in the cases provided for in Article 40 paragraph 2 and Article 41 paragraphs 4 and 7 of the Tourism Code and art. 11 of the Summer Camp General Terms and Conditions will incur a penalty.

The amount of the penalty will be calculated by adding to the possible cost of the Facilitated Cancellation, if signed, the cost for other requested services already rendered, and the following percentages of the participation fee, calculated on the basis of how many days before the start of the tourist package the cancellation took place (the calculation of the days does not include that of withdrawal, whose communication must be received on a working day prior to the start of the package):

- up to 21 days before departure 25%;
- from 20 to 5 days before departure 50%;
- from 4 to 0 days before departure 90%;
- 100% stay started.

- **Conditions of substitution (art. 14 of the General Conditions)**

The terms and conditions of substitution are governed by Article 14 of the Summer Camp General Terms and Conditions.

- **Documents required for the use of the package (art. 15 and 16 of the General Conditions)**

(i) English Camp Package in the United Kingdom, for Italian citizens: individual passport or personal document valid for travel abroad, in addition to the requirements indicated, with regard to the exit from the country of minors under the age of 14 and for those for which the Authorization issued by the Judicial Authority is required, on the website of the State Police <http://www.poliziadistato.it/articolo/191/> and any ETA authorization if necessary at the time of travel.

(ii) Certificate attesting to the absence of infectious syndromes

(iii) Registration form to be filled in digitally by the Parent via a link sent to the latter's email address

(iv) Medical certificate of fitness for competitive or non-competitive sporting activity;

(vi) shock-absorbing protective goggles with celluloid frames and shatterproof polycarbonate prescription lenses (if glasses are required)

Foreign citizens must obtain information for entry into Italy or the United Kingdom through their diplomatic representations present and/or follow the information and instructions for entry into Italy published by the Ministry of Foreign Affairs (<https://vistoperitalia.esteri.it/home.aspx>). In any case, the Participant must check with the competent authorities before departure and comply with them before travelling.

In any case, the Purchaser must inform the Organizer of the Participant's citizenship and residence at the time of the booking request for the tourist package, who, at the time of departure, must definitively verify that he is in possession of the individual identity document and any other valid document, as well as the residence visas, transit visas and health certificates that may be required.

In addition, in order to assess the situation of social/political security, health and any other useful information relating to the country of destination and, therefore, the objective usability of the services purchased or to be purchased, the Purchaser is responsible for obtaining official information of a general nature from the Ministry of Foreign Affairs, and disseminated through the institutional website of the Ministry of Foreign Affairs [www.viaggiare Sicuri.it](http://www.viaggiare Sicuri.it).

The above information is not contained in the catalogues of the T.O. – online or paper – since they contain descriptive information of a general nature as indicated in Article 34 of the Tourism Code and not temporally changing information. Therefore, they must be assumed by the Buyer and the Participant. No responsibility will be attributable to the Organizer for any damage that may arise to the Participants due to the impossibility of starting and/or continuing the trip, due to the lack or irregularity of the prescribed documents and/or the failure to comply with the health obligations and related formalities provided for in the country of destination. Therefore, the Organizer cannot be held responsible for the non-departure of the Participant and, therefore, will not make any refund for the price of the stay or additional expenses (cancellation, repatriation, hotel, taxi, etc.).

For more information, please refer to articles 15 ("Mandatory declarations and Certificates necessary for the use of the package to be sent before the start of the trip") and 16 ("Obligations of the Participant") of the Summer Camp General Conditions.

- **Cancellation insurance (Art. 23 of the General Terms and Conditions)**

The participation fee does not include insurance for cancellation costs. It is possible to stipulate the Early Termination Agreement at the time of booking the tourist package, which only operates under certain circumstances. It is also possible to take out special insurance policies against package cancellation fees. In this case, the rights arising from the insurance contracts must be exercised directly against the contracting Insurance Companies, under the conditions and in the manner provided for by such policies.

- **Information pursuant to art. 13 of Legislative Decree 196/2003 and Article 13 of Regulation (EU) 2016/679**

The data communicated by the Purchaser, necessary for the execution of the tourist package contract, are processed in accordance with the provisions of the above-mentioned legislation (European Regulation 679/2016 and Legislative Decree 196/2003 and subsequent amendments) and the confidentiality obligations to which the Organizer is bound with regard to the protection of personal data. The personal and special data provided as part of the Summer Camp package travel contract are processed to allow the management of the order form, the conclusion and execution of the tourist package contract, to provide assistance services and to manage payments. For the performance of the services covered by the tourist package contract, the data are communicated to the providers of the services included in the tourist package. The data subject may at any time exercise the rights that the

applicable legislation on the protection of personal data attributes to him/her. For further information on the processing of personal data by the Organiser, please refer to the Information on the processing of personal data specific to the Juventus Summer Camps published in the Legal Camp Information section.

- **Mandatory communication pursuant to Article 17 of Law No. 38/2006**

Italian law punishes with imprisonment crimes relating to prostitution and child pornography, even if committed abroad.

## **FACILITATED CANCELLATION**

1. The "Facilitated Cancellation" cancellation agreement, which can be signed at the same time as the Contract, allows the Participant to withdraw from the Contract and cancel the registration for the Juventus Summer Camp upon the occurrence of the conditions set forth in art. 3 below.

2. The cancellation agreement provides for the payment of an additional non-refundable sum of € 45.00 for 1-week packages in the towns of Sestriere, Vinovo, Pinzolo and Chianciano Terme, equal to € 90.00 for 1-week packages at the MasterClass Camp Torino and for 2-week packages in the resorts of Sestriere, Vinovo, Pinzolo and Chianciano Terme, equal to € 150.00 for 2-week packages at the MasterClass Camp Torino, at the Juventus English Camp.

3. The Organiser recognises that the Participant has the right to withdraw from the Contract in the following cases:

- death, illness (including Covid 19 infection) or injury of the participant, parents, brothers, sisters, daughters-in-law, grandparents, uncles and nephews up to the 3rd degree of kinship;
- inability of the Insured to reach the place of departure following serious natural disasters declared by the competent authorities;
- breakdown or accident of the means of transport used by the insured person that prevents him/her from reaching the place of departure of the journey;
- theft of the documents necessary for expatriation, when it is proven that it is materially impossible to remake them in time for departure;
- inability to undertake the journey following the change in the date of the school exam session;
- impossibility to undertake the journey in the event that, in the 7 days prior to departure, the dog or cat owned by the latter (duly registered) must undergo an urgent life-saving surgery due to the animal's injury or illness.

4. This cancellation agreement must be requested and stipulated, by checking the relevant box, strictly at the time of filling in the Order Form and the amount provided for it must be paid at the same time as the payment of the Participation Fee, otherwise it will not be effective.

5. The Facilitated Cancellation Agreement must be signed at the time of sending the Order Form and the amount provided for must be paid at the same time as the payment of the Participation Fee. The notice of withdrawal must be promptly provided to Holiday System by email to the address [jvesummecamp@jcamp.it](mailto:jvesummecamp@jcamp.it) attaching the certification proving the serious reason. A refund is excluded if the Participant has not communicated the request for withdrawal to the Organiser within 5 days from the date of the occurrence of the event and in all cases in which the Camp has started.

6. In case of exercise of the right of withdrawal pursuant to Article 5 above, the Organizer will reimburse all sums paid by the Purchaser on behalf of the Participant within 14 (fourteen) working days from receipt of the documentation proving the right to exercise the right of withdrawal, without prejudice to the cost
