- Residential and English Camps only: Accommodation in 2-4 bed rooms.
- Non-residential Camps only: Lunch and one daily snack (menu designed by experts).
- Supervision and assistance services.
- Medical assistance.
- Civil liability insurance.
- Accident insurance.
- Welcome kit as detailed on the Website.
- Training and technical instruction by Juventus project staff, including FIGC-licensed coaches and/or graduates in sports science.
- Leisure and entertainment activities managed by dedicated staff.
- A tour of the Juventus Stadium in Turin, including a visit to the Museum (for Masterclass Camp and Sestriere Camp participants).
- Air travel, airport taxes, and transfer by GT coach from the airport to the college and vice versa (for English Camp packages only).
- English lessons taught by qualified native-speaking teachers (English Camp packages only).

The Organizer reserves the right to cancel the package in the event that the minimum number of participants is not reached. Written notice will be provided at least 20 days prior to the start date of the package. In such cases, Article 10 of the General Terms and Conditions of Contract will apply.

Payments (art. 6 of the General Conditions)

<u>For bookings made by May 8, 2025</u>, the Buyer must pay a deposit on the Total Price, which includes a portion of the participation fee and the full cost of the Cancellation Option (if selected) within seven days of submitting the Order Form, using a credit card or bank transfer.

The remaining balance of the Total Price must be paid via bank transfer:

 - o Pinzolo: Turn 4

The deposit can be paid by credit card (Visa or Mastercard) or prepaid card, as well as by bank transfer. The balance must be paid by bank transfer to the following account:

Payment is considered complete when the funds are received by the Organizer.

<u>For bookings submitted after May 8, 2025</u>, the Buyer must pay the Total Price, including the Cancellation Option cost (if selected), at the time of submitting the Order Form.

When sending the Order Form, the Purchaser may also, if provided by the Organiser for the package selected at the time of purchase, choose the financed payment formula, which can be optioned in the booking process, through financing offered by the partner Compass Banca S.p.A. with the Heylight tool, (hereinafter "Heylight"). In this case, the Buyer will be directed directly to Heylight's online platform where he/she will have to enter the data necessary to request the loan and, no later than the following 7 days, he/she will have to send Heylight the documentation requested by the latter for the finalization of the loan contract. The financing contract will be formalized between the Buyer and Heylight, without any liability or obligation on the part of the Organizer. The amount financed will refer to the Total Price to be paid (including the Participation Fee and the amount of the Facilitated Cancellation, if signed). In the event that Heylight does not authorize the requested financing, the Buyer must directly pay the Total Price.

Online Sales Cancellation - Exclusion of Right of Withdrawal

The contract, as it falls under the category of "distance contracts" according to Article 45, paragraph 1, letter g of the Consumer Code ("any contract concluded between the Professional and the consumer within the framework of an organized system of distance selling or provision of services, without the simultaneous physical presence of the Professional and the consumer, using one or more means of distance communication up to the conclusion of the contract"), is not subject to the right of withdrawal pursuant to Article 47, paragraph 1, letter g of the Consumer Code, which governs and lists cases of exclusion.

However, the Participant may withdraw from the contract at any time before the start of the package by paying the withdrawal fees (penalties) outlined below under "Participant Withdrawal and Penalties."

Participant Withdrawal and Penalties (Article 11 of the General Terms and Conditions)

If the Participant withdraws from the contract before departure, for any reason, including unforeseen or sudden circumstances, outside the cases specified in Article 40, paragraph 2, and Article 41, paragraphs 4 and 7 of the Tourism Code and Article 11 of the Summer Camp General Conditions, a penalty will apply.

The penalty amount will be calculated as follows:

- Up to 21 days before departure: 25% of the participation fee.
- From 20 to 5 days before departure: 50% of the participation fee.
- From 4 to 0 days before departure: 90% of the participation fee.
- After the start of the stay: 100% of the participation fee.

The penalty will include the following:

- The cost of the optional Cancellation Option, if selected.
- Costs for any requested services already rendered.

The calculation of days does not include the withdrawal day, and the withdrawal notice must be received on a business day prior to the start of the package.

Substitution Conditions (Article 14 of the General Terms and Conditions)

The terms and conditions for participant substitution are outlined in Article 14 of the Summer Camp General Conditions.

Required Documents for Package Use (Articles 15 and 16 of the General Terms and Conditions)

The following documents are necessary to access the Juventus Summer Camp package:

- 1. For English Camp in the UK (Italian citizens):
 - An individual passport or valid ID for travel abroad, along with any necessary permits for minors under 14 years of age, as specified on the Italian State Police website (<u>link</u>).
 - o Authorization, such as an ETA, if required at the time of travel.
- 2. Certificate of absence of infectious diseases.
- 3. **Registration form**, completed digitally by the parent via a link sent to their email.
- 4. **Medical certificate** of fitness for athletic or non-athletic activities.
- 5. **Protective eyewear** (if glasses are needed), made of celluloid with unbreakable lenses in polycarbonate.

Foreign citizens should obtain information about entry into Italy or the UK from their diplomatic representations or via the Italian Ministry of Foreign Affairs (<u>link</u>). Participants must ensure that they have valid personal identification, visas, and any required health certificates.

No liability is attributed to the Organizer for damages resulting from the Participant's inability to start or continue the trip due to missing or invalid documents.

Cancellation Insurance (Article 23 of the General Terms and Conditions)

The participation fee does not include cancellation insurance. Optional insurance for cancellation fees may be purchased during package booking. Such agreements are only valid under specific circumstances. Claims must be made directly with the issuing insurance companies, following the terms and conditions of the respective policies.

Information pursuant to art. 13 of Legislative Decree 196/2003 and Article 13 of Regulation (EU) 2016/679

The data communicated by the Purchaser, necessary for the execution of the tourist package contract, are processed in accordance with the provisions of the aforementioned legislation (European Regulation 679/2016 and Legislative Decree 196/2003 and subsequent amendments) and the confidentiality obligations to which the Organiser is bound in terms of the protection of personal data. The personal and special data provided within the framework of the Summer Camp tourist package contract are processed to allow the management of the order form, the conclusion and execution of the tourist package contract, to provide assistance services and to manage payments. For the performance of the services covered by the tourist package contract, the data are communicated to the suppliers of the services included in the tourist package. The data subject may at any time exercise the rights that the applicable legislation on the protection of personal data attributes to him/her. For further information on the processing of personal data by the Organiser, please refer to the Information relating to the processing of personal data specific to the Juventus Summer Camps published in the Camp Legal Information section.

Mandatory communication pursuant to Article 17 of Law no. 38/2006

Italian law punishes crimes concerning prostitution and child pornography with imprisonment, even if committed abroad.

Early Cancellation Option (Disdetta Agevolata)

- 1. The "Early Cancellation Option," which can be subscribed to at the time of the contract, allows the Participant to withdraw from the Contract and cancel their registration for the Juventus Summer Camp under the conditions specified in Article 3 below.
- 2. The agreement requires an additional non-refundable fee:
 - €45.00 for 1-week packages in Sestriere, Vinovo, Pinzolo, and Chianciano Terme.
 - o €90.00 for 1-week packages at the MasterClass Camp in Turin and for 2-week packages in Sestriere, Vinovo, Pinzolo, and Chianciano Terme.
 - €150.00 for 2-week packages at the MasterClass Camp in Turin and for the Juventus English Camp.
- 3. The Organizer grants the Participant the right to withdraw from the Contract in the following cases:
 - O Death, illness, or injury of the Participant or their immediate family members (parents, siblings, grandparents, uncles, nieces, and nephews up to the third degree of kinship).
 - o Inability to reach the departure location due to serious natural disasters officially declared by the relevant authorities.
 - Breakdown or accident involving the transport used by the insured, preventing them from reaching the departure location.
 - Theft of travel documents, provided it is proven that replacement was not possible in time for departure.
 - Changes to the date of an academic exam session preventing travel.
 - Urgent life-saving surgery required for the insured's registered dog or cat within 7 days prior to departure.
- 4. The Early Cancellation Option must be requested and subscribed to by selecting the relevant option during the completion of the Order Form. The associated fee must be paid at the same time as the participation fee; otherwise, it will not be valid.
- 5. In case of withdrawal under the terms of the Easy Cancellation Option, the Participant must promptly notify Holiday System via email at **juvesummercamp@jcamp.it**, attaching documentation that certifies the serious reason for withdrawal. Refunds are excluded if the Participant fails to notify the Organizer within 5 days of the event or if the camp has already started.
- 6. If the Participant exercises their right to withdraw according to the terms above, the Organizer will refund all amounts paid by the Buyer on behalf of the Participant within 14 working days of receiving the required documentation, except for the non-refundable fee for the Easy Cancellation Option.
